

## Georgia Lottery Corporation – Cash Pop Mystery Box Second Chance Giveaway Promotion

### Official Rules – 2/06/23

#### **1. Eligibility:**

The Georgia Lottery Corporation's Cash Pop Mystery Box Second Chance Giveaway Promotion ("the Promotion") is open to each eligible original purchaser of a Georgia Lottery non-winning Cash Pop Ticket or share legally purchased through official GLC sales channels between February 6, 2023, and March 12, 2023 ("ENTRANT"). An Entrant must also be a legal resident of the United States, who is 18 years of age or older. Employees of the Georgia Lottery Corporation ("GLC" or "Georgia Lottery" or "Sponsor"), IGT Corporation, IGT International, BBDO Atlanta, Scientific Games, LLC, MDI Entertainment, LLC, AppHub, LLC, and their respective parent companies, affiliates, subsidiaries, directors, officers, agents, contractors, advertising/promotional agencies, (collectively, "Sponsors"), and immediate family members living in the same household of each are not eligible. Void where prohibited by law.

#### **2. Entries and Drawings:**

An Entrant may submit an entry of any non-winning Cash Pop ticket issued by the Georgia Lottery that is purchased at retail between February 6, 2023, and March 12, 2023, along with other required information as specified on the Georgia Lottery's Cash Pop Mystery Box Second Chance Giveaway promotional website at <http://PlayCashPop.com>. Any Cash Pop ticket or share purchased between February 6, 2023, and March 12, 2023, either (a) online via the GLC official webpage at [www.galottery.com](http://www.galottery.com), or (b) via the GLC mobile app, will be automatically entered in the Promotion as of the date and time purchased. Each ticket or share will count as one entry regardless of the price paid for the ticket or share.

Drawings are scheduled to occur on the dates shown below. Unless otherwise provided in these Official Rules, Entries submitted between the start and end dates for a specific Weekly Drawing, as shown below, are eligible for that Drawing for both the \$5,000 Cash Prizes and the entry into the Live Mystery Box Selection Contests. As shown below, for each Weekly Drawing: (a) five (5) \$5,000 Cash Prizes will be awarded in the Drawing; and (b) one (1) entry into the Live Mystery Box Selection Contests will be awarded in the Drawing to select a single mystery box prize package valued \$5,000 to \$30,000. Non-winning Cash Pop ticket entries for any Weekly Drawing will not carry over to any subsequent Weekly Drawings. Thus, any valid entry is only eligible for one (1) Weekly Drawing. Entrants drawn for the Live Mystery Box Selection Contests as a Live Event Contestant, will only have a choice to select from five (5) prizes. A total of fourteen (14) various Mystery Box prize packages, retail valued \$5,000 to \$30,000, will be offered throughout this Mystery Box Prize. GLC representatives, upon conclusion of each Live Mystery Box Selection Contest, will confirm the total estimated retail value amount that will be awarded to the Live Event selection Contestant, in the presence of the Live Event Mystery Box Selection Contestant; in accordance with these Rules..

Thus, any valid entry is eligible for one (1) Weekly Drawing, as shown below. Eligible non-winning Cash Pop tickets may be entered at any time during this Promotion, regardless of the date purchased during the Promotion period. However, each eligible, non-winning Cash Pop ticket may only be entered one time in total during this Promotion, and no eligible, non-winning Cash Pop ticket or share may win more than one prize in total. The GLC may assign various promotional names or themes for some or all the scheduled Drawings. However, the entry periods, Drawing dates, and prizes awarded for each Drawing shall not be affected thereby. Entry deadlines are subject to change by the Georgia Lottery. Drawing dates are two days following the deadline for submitting entries for each Entry Period. The GLC reserves the right to change any Drawing Dates.

On each Weekly Drawing date, six (6) eligible entries will be randomly selected as Weekly Prize winners from all eligible entries received during the corresponding entry period. Odds of winning depend on the total number of eligible entries received for each Drawing. Entries received after the entry period for any Drawing will not be eligible for that Drawing but may be eligible for subsequent Drawings during the same Promotion, if any.

The Georgia Lottery Corporation reserves the right to cancel or postpone scheduled Drawings, to conduct additional Drawings and award additional prizes, or to substitute prizes of equivalent value or increase the value of prizes awarded for any scheduled Drawings within the Promotion. Any amendments to the Promotion will be posted on the Georgia Lottery Corporation promotional website at <http://PlayCashPop.com>.

To enter the Promotion, an entrant must go to the GLC promotional website, <http://PlayCashPop.com> and follow the instructions and provide the information requested therein. Any Cash Pop ticket or share purchased either (a) online via the GLC official webpage at [www.galottery.com](http://www.galottery.com), or (b) via the GLC mobile app, will be automatically entered in the Promotion as of the date and time purchased. Mailed entries or any other attempted form of entry in this Promotion will not be accepted.

Entrants must follow the on-screen instructions to enter. Entries of canceled or winning Cash Pop tickets and multiple entries using the same Cash Pop ticket will be disqualified. If multiple entries are submitted with the same ticket number, only the first entry submitted will be valid. If a person attempts to enter any ticket that the person did not purchase himself/herself at retail, all of that person's entries may be disqualified. The computer clock of Sponsor's webmaster is the official timekeeping device of the Promotion. Proof of submission does not constitute proof of delivery or entry.

Each entry submitted of a Cash Pop ticket purchased at retail must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of such entries (including, but not limited to, entries made using any script, macro, bot, or sweepstakes service), will not be accepted and will be disqualified. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the operation of the Promotion or to be acting in violation of these Official Rules.

Sponsors are not responsible for incomplete, lost, late, damaged, illegible, garbled, misdirected, forged, e-mail or for any technical problems, malfunctions of any telephone lines, computer systems, servers, providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled, or delayed computer transmission or any combination thereof. Sponsor is not responsible for any damage to any individual's computer system/software related to or resulting from participation or downloading any material in this Promotion. **CAUTION: ANY ATTEMPT BY AN INDIVIDUAL TO DAMAGE ANY WEBSITE OR UNDERMINE THE LEGITIMATE OPERATION OF THIS PROMOTION IS A VIOLATION OF CRIMINAL AND CIVIL LAW. SHOULD SUCH AN ATTEMPT BE MADE, SPONSOR RESERVES THE RIGHT TO SEEK DAMAGES FROM ANY SUCH INDIVIDUAL OR PROSECUTE TO THE FULLEST EXTENT PERMITTED BY LAW.**

If, for any reason, the Promotion is not capable of running as planned due to, without limitation, errors in these Official Rules, infection by computer virus, bugs, tampering, unauthorized

intervention, fraud, technical failures, insufficient sales, epidemic or pandemic, or any other causes outside control of Sponsor which impair or affect the administration, security, fairness, integrity or proper conduct of this Promotion, the GLC reserves the right, at its sole discretion, to cancel, modify, terminate, postpone, or suspend the Promotion. In the event of termination, a notice will be posted on the Georgia Lottery's Cash Pop Mystery Box Second Chance Giveaway promotional website at <http://PlayCashPop.com>.

### **3. Prizes:**

The top prize packages awarded for selection in the Promotion will vary in value from \$5,000 to \$30,000. All prizes will be cash prizes and will be awarded in the form of a check, less any required tax or other withholdings. One weekly winner will win an appearance at a Live Prize Selection event to select one (1) of five (5) mystery boxes, representing cash, merchandise, or experience presentations, each valued \$5,000 to \$30,000. Each Weekly Cash Prize winner will win \$5,000 each. Five (5) \$5,000 cash prizes will be awarded in each Weekly Drawing. All Mystery Box top prizes will be awarded the cash value and not the advertised merchandise. However, the GLC reserves the right in its sole discretion to substitute prizes of equivalent value, to increase the value of prizes awarded, and/or to increase the number of prizes awarded in any scheduled Drawing.

If an entry is disqualified prior to the time that the Drawing is finalized, an alternate entry may be substituted for the weekly second chance drawing. Each Drawing may consist of more than one drawing if circumstances occur to invalidate the drawing. Regardless of the number of supplemental Drawings required to complete a Drawing, only five (5) \$5,000 Cash Prizes and only one (1) Live Mystery Box Selection Contest Prize will be awarded per each Weekly Drawing period. Prizes are not transferable, and no substitutes for prizes will be available, except by Sponsor, which reserves the right, in its sole discretion, to substitute different prizes of comparable value.

### **4. Proxy for Live Event Contestants (if necessary)**

In consideration of some limitations that may occur in the planning and engagement of the Live Prize Selection event via Facebook Live communication required by entrants, A proxy may be designated on one of the following ways:

Each Live Selection Event Contestant may assign a proxy to participate in the Live Contest on their behalf. Prizes that may be won by the proxy shall be awarded to the Live Selection Event Contestant (less applicable tax and other required withholdings).

If the Live Event Contestant fails to arrive for the Live Contest for his or her scheduled participation or is otherwise unable to participate in the Live Contest (by reason of illness, health, physical limitations, or otherwise), then the GLC will appoint a proxy to participate in the Live Selection Event Contest for the Live Event Contestant. Prizes that may be won by the proxy shall be awarded to the Live Selection Event Contestant (less applicable tax and other required withholdings); or

If the Live Selection Event Contestant does not designate a proxy and a proxy is otherwise necessary to participate in the Live Event on his or her behalf, for any reason whatsoever as determined in the sole discretion of the GLC, the GLC will appoint a proxy to participate on his or her behalf. The Live Event Contestant acknowledges that the proxy appointed by the GLC will have to make decisions on behalf of the Live Selection Event Contestant and therefore, the Live Selection Event Contestant delegates the power, authority or discretion to the proxy appointed by the GLC to make any such decisions on the Live Event Contestant's behalf. The Live Event Contestant shall receive any **Mystery Box Prize(s)** won by the GLC appointed proxy in the Live Contest (less applicable tax and other required withholdings).

## **5. Notification of Winners**

The Georgia Lottery Corporation will attempt to contact each winner via telephone call at the telephone number provided, by email message at the email address provided, or by mail at the street address provided. Any prize winner whose Winner Notification is returned undeliverable due to blocked emails, incorrect address information, or expired forwarding address notifications will forfeit the opportunity to win the prize.

Prize winners of prizes greater than \$600 will be required to complete, sign, and return a Winner Claim form, Affidavit of Eligibility, and Liability/Publicity Release, and furnish his or her Social Security Number for federal and state tax reporting and withholding purposes. The winners of the weekly \$5,000 prizes must provide the required documents within **twenty-one (21) days of the drawing**. The winners of the Mystery Box Event Contestant prize must provide the required documents within **seven (7) days of the drawing** in order to coordinate their participation in the event. If, after reasonable attempts to contact a prize winner by the Georgia Lottery Corporation, a prize winner cannot be contacted or does not return any required form(s) or information **by the required deadline**, an alternate Entrant will be awarded the prize. Any Prizes valued greater than \$5,000 that are awarded in this Promotion are subject to the debt setoff requirements of the Georgia Lottery for Education Act, O.C.G.A. § 50-27-50 *et seq.* and winners must satisfy those requirements before claiming such Prize. Upon the satisfactory timely return of all required forms and verification of eligibility, the GLC shall deliver or mail prize checks to the \$5,000 prize winners or coordinate their participation in the Mystery Box Event, if applicable.

Acceptance of a Prize shall further constitute and signify the Prize Winner's agreement and consent that Sponsor may use the Prize Winner's name, likeness and/or prize and biographical information worldwide without limitation and without further compensation, except where expressly prohibited by law.

## **6. General Provisions:**

The Georgia Lottery Corporation, IGT Corporation, IGT International, BBDO Atlanta, Scientific Games, LLC, MDI Entertainment, LLC, AppHub, LLC, and their respective parent companies, affiliates, subsidiaries, directors, officers, agents, contractors, advertising/promotional agencies, and employees assume no liability or responsibility for damages, losses, or injury resulting from

this promotion or acceptance or use of a prize. All taxes and incidental expenses are the sole responsibility of a Prize Winner. All federal, state, and local laws and regulations shall apply.

By participating in the Promotion, all participants and Prize Winners agree to the Georgia Lottery's Cash Pop Mystery Box Second Chance Giveaway Promotion Official Rules and the decisions of the Georgia Lottery, whose decisions shall be final in all respects and legally binding in all matters related to this Promotion. All participants and Prize Winners agree to release and discharge, hold harmless and indemnify Sponsor and Sponsors against any and all liability whatsoever for any injuries, losses, harm, damage (including but not limited to property damage, personal injury and/or death), claims, actions, costs and expenses (including without limitation, all attorney's fees and court costs) arising directly or indirectly from or in connection with his/her participation in the Promotion, acceptance, possession or use/misuse of the prize or participation in any prize-related activity, including but not limited to any travel related thereto or any goods/services provided in connection with any prize. Participants further acknowledge that Sponsor and Sponsors are in no manner responsible or liable for, any warranty, representation, or guarantee, express or implied, in fact or in law, relative to any prize, including but not limited to its quality, mechanical condition or fitness for a particular purpose. Any and all warranties and/or guarantees of a prize (if any) are subject to the respective manufacturers' terms; therefore, Prize Winners agree to look solely to such manufacturers for any such warranty and/or guarantee. Sponsor reserves the right to take such action as it deems necessary to enforce these Official Rules and ensure the fair operation of the Promotion, including without limitation, barring and disqualifying individuals who do not comply with these Official Rules. By entering, participants agree that all issues and questions concerning the construction, validity, interpretation and enforceability of these Official Rules, participants' rights and obligations, or the rights and obligations of the Sponsor and Sponsors in connection with the Promotion shall be governed by, and construed in accordance with, the laws of the State of Georgia, without giving effect to any choice of law or conflict of law rules. By entering, participants consent to the jurisdiction and venue of the Superior Court of Fulton County, located in Atlanta, Georgia. Records related to the Promotion (including, but not limited to, Entries, Drawing results and winners lists) will be retained for a period of one-hundred eighty (180) days after the last Drawing date.
