

Georgia Lottery Corporation – Cash Pop Second Chance Giveaway Promotion
Rules – 9/30/20

1. Eligibility:

The Georgia Lottery Corporation's Cash Pop Second Chance Giveaway Promotion ("the Promotion") is open to each eligible original purchaser of a Georgia Lottery non-winning Cash Pop Ticket legally purchased through official GLC sales channels between October 5, 2020, and October 3, 2021 ("ENTRANT"). An Entrant must also be a legal resident of the United States, who is 18 years of age or older. Employees of the Georgia Lottery Corporation ("GLC" or "Georgia Lottery" or "Sponsor"), IGT Corporation, IGT International, BBDO Atlanta, Scientific Games Inc., MDI Entertainment, LLC, Viralsweep, LLC, and their respective parent companies, affiliates, subsidiaries, directors, officers, agents, contractors, advertising/promotional agencies, (collectively, "Sponsors"), and immediate family members living in the same household of each are not eligible. Void where prohibited by law.

2. Entries and Drawings:

An Entrant may submit an entry of any non-winning Cash Pop ticket issued by the Georgia Lottery that is purchased at retail between October 5, 2020, and October 3, 2021, along with other required information as specified on the Georgia Lottery's Cash Pop Second Chance Giveaway promotional website at <http://PlayCashPop.com>. Any Cash Pop ticket purchased between October 5, 2020, and October 3, 2021, either (a) online via the GLC official webpage at www.galottery.com, or (b) via the GLC mobile app, will be automatically entered in the Promotion as of the date and time purchased. Each ticket will count as one entry regardless of the price paid for the ticket.

Drawings are scheduled to occur on the dates shown below. There will be three (3) types of Drawings during the Promotion: (1) Weekly Drawings will occur every seven (7) days; (2) Monthly Drawings will occur every four (4) or five (5) weeks, as shown below; and (3) Quarterly Drawings will occur approximately every 91 days. Entries are eligible for Weekly, Monthly, and Quarterly Drawings. All entries submitted between the start and end dates for a specific Drawing, as shown below, are eligible for that Drawing. Non-winning entries for any Weekly Drawing will not carry over to any subsequent Weekly Drawings; non-winning entries for any Monthly Drawing will not carry over to any subsequent Monthly Drawings; and non-winning entries for any Quarterly Drawing will not carry over to any subsequent Quarterly Drawings. Thus, any valid entry is eligible for one (1) Weekly Drawing, one (1) Monthly Drawing, and one (1) Quarterly Drawing, as shown below. Eligible non-winning tickets may be submitted at any time during this Promotion, regardless of the date purchased during the Promotion period. However, each eligible, non-winning Cash Pop ticket may only be submitted one time in total during this Promotion, and no eligible, non-winning Cash Pop ticket may win more than one prize in total. The GLC may assign various promotional names or themes for some or all of the scheduled Drawings. However, the entry periods, Drawing dates, and prizes awarded for each

Drawing shall not be affected thereby. Entry deadlines are subject to change by the Georgia Lottery. Entry submission deadlines and Drawing dates are posted on <http://PlayCashPop.com> and listed below:

Drawing dates are two days following the deadline for submitting entries for each Entry Period. The GLC reserves the right to change any Drawing Dates.

On each Weekly Drawing date, five (5) eligible entries will be randomly selected as Weekly Prize winners from all eligible entries received during the corresponding entry period. On each Monthly Drawing date, four (4) eligible entries will be randomly selected as Monthly Prize winners from all eligible entries received during the corresponding entry period. On each Quarterly Drawing date, twenty (20) eligible entries will be randomly selected as Quarterly Prize winners from all eligible entries received during the corresponding entry period. Odds of winning depend on the total number of eligible entries received for each Drawing. Entries received after the entry period for any Drawing will not be eligible for that Drawing but may be eligible for subsequent Drawings during the same quarter, if any.

The Georgia Lottery Corporation reserves the right to cancel or postpone scheduled Drawings, to conduct additional Drawings and award additional prizes, or to substitute prizes of equivalent

value or increase the value of prizes awarded for any scheduled Drawings within the Promotion. Any amendments to the Promotion will be posted on the Georgia Lottery Corporation promotional website at <http://PlayCashPop.com>.

To enter the Promotion, an entrant must go to the GLC promotional website, <http://PlayCashPop.com> and follow the instructions and provide the information requested therein. Mailed entries or any other attempted form of entry in this Promotion will not be accepted.

Entrants must follow the on-screen instructions to enter. Entries of canceled or winning Cash Pop tickets and multiple entries using the same Cash Pop ticket will be disqualified. If multiple entries are submitted with the same ticket number, only the first entry submitted will be valid. If a person attempts to enter any ticket that the person did not purchase himself/herself at retail, all of that person's entries may be disqualified. The computer clock of Sponsor's webmaster is the official timekeeping device of the Promotion. Proof of submission does not constitute proof of delivery or entry.

Each entry submitted of a Cash Pop ticket purchased at retail must be manually key stroked and manually entered by the individual Entrant; automated and/or repetitive electronic submission of such entries (including, but not limited to, entries made using any script, macro, bot or sweepstakes service), will be not be accepted and will be disqualified. Sponsor reserves the right in its sole discretion to disqualify any individual it finds to be tampering with the operation of the Promotion or to be acting in violation of these Official Rules.

Sponsors are not responsible for incomplete, lost, late, damaged, illegible, garbled, misdirected, forged, e-mail or for any technical problems, malfunctions of any telephone lines, computer systems, servers, providers, hardware/software, lost or unavailable network connections or failed, incomplete, garbled or delayed computer transmission or any combination thereof. Sponsor is not responsible for any damage to any individual's computer system/software related to or resulting from participation or downloading any material in this Promotion. If, for any reason, the Promotion is not capable of running as planned due to, without limitation, errors in these Official Rules, infection by computer virus, bugs, tampering, unauthorized intervention, fraud, technical failures, insufficient sales, epidemic or pandemic, or any other causes outside control of Sponsor which impair or affect the administration, security, fairness, integrity or proper conduct of this Promotion, the GLC reserves the right, at its sole discretion, to cancel, modify, terminate, postpone, or suspend the Promotion. 3. Prizes:

All prizes in the Promotion will be VISA gift cards of varying amounts. No cash prizes will be awarded. Each Weekly Prize winner will win a \$100 VISA gift card. Five (5) \$100 VISA gift cards will be awarded in each Weekly Drawing. Each Monthly Prize winner will win a \$250 VISA gift card. Four (4) \$250 VISA gift cards will be awarded in each Monthly Drawing. Each Quarterly Prize winner will win a \$500 VISA gift card. Twenty (20) \$500 gift cards will be awarded in each Quarterly Drawing. However, the GLC reserves the right in its sole discretion to substitute prizes of equivalent value, to increase the value of prizes awarded, and/or to increase the number of prizes awarded in any scheduled Drawing.

If an entry is disqualified prior to the time that the Drawing is finalized, an alternate entry may be substituted for the entry drawn. Each Drawing may consist of more than one drawing if circumstances occur to invalidate the drawing. Regardless of the number of supplemental Drawings required to complete a Drawing, only five Weekly Prizes will be awarded per each Weekly Drawing period, four Monthly Prizes will be awarded per each Monthly Drawing Period, and twenty Quarterly Prizes will be awarded per each Quarterly Drawing period. Prizes are not transferable, and no substitutes for prizes will be available, except by Sponsor, which reserves the right, in its sole discretion, to substitute different prizes of comparable value.

4. Notification of Winners

The Georgia Lottery Corporation will attempt to contact each winner via telephone call at the telephone number provided, by email message at the email address provided, or by mail at the street address provided. Any prize winner whose Winner Notification is returned undeliverable due to blocked emails, incorrect address information, or expired forwarding address notifications will forfeit the opportunity to win the prize. Prize winners of prizes greater than \$600 will be required to complete, sign, and return a Winner Claim form, Affidavit of Eligibility, and Liability/Publicity Release, and furnish his or her Social Security Number for federal and state tax reporting and withholding purposes within twenty-one (21) days of the drawing. If, after reasonable attempts to contact a prize winner by the Georgia Lottery Corporation, a prize winner cannot be contacted or does not return any required form(s) or information within twenty-one (21) days of the drawing, the prize may be forfeited. In the event a prize valued greater than \$600 is forfeited, an alternate Entrant will be awarded the prize. Any Prizes valued greater than \$2,500 that are awarded in this Promotion are subject to the debt setoff requirements of the Georgia Lottery for Education Act, O.C.G.A. § 50-27-50 *et seq.* and winners must satisfy those requirements before claiming such Prize. Upon the satisfactory timely return of all required forms and verification of eligibility, the GLC shall send gift card prizes via email to the email address provided by the winner.

Acceptance of a Prize shall further constitute and signify the Prize Winner's agreement and consent that Sponsor may use the Prize Winner's name, likeness and/or prize and biographical information worldwide without limitation and without further compensation, except where expressly prohibited by law.

All taxes and incidental expenses are the sole responsibility of a Prize Winner. All federal, state, and local laws and regulations shall apply.

By participating in the Promotion, all participants and Prize Winners agree to the Georgia Lottery's Cash Pop Second Chance Giveaway Promotion Official Rules and the decisions of the Georgia Lottery, whose decisions shall be final in all respects and legally binding in all matters related to this Promotion.
